




MARCH 8TH




MARCH 9TH

Impacts – both positive and negative – of changing recreation trends on local residents and Indigenous communities in the Crown.

During this day, we will examine the ecological changes that new recreation trends bring to local communities and consider how these changes are perceived and experienced by residents. We will gain understanding of impacts to cultural resources and learn from Tribes and First Nations on how to best manage culturally significant areas. During our closing panel, we will learn how the Crown Managers Partnership conservation priorities (a set of ecological priorities that are shared and agreed upon by agency/government land managers across the Crown) are affected by recreation trends.
